BACKGROUND

An Environmental Impact Assessment (EIA) [Basic Assessment process] has commenced to assist the Limpopo Department of Economic Development, Environment and Tourism (LEDET) in determining the extent and significance of the environmental consequences associated with the proposed development of Rethuseng Special School.

Notice of Basic Assessment Process is given in terms of regulations published in Government Gazette No. R982, under Section 40(1) of the National Environmental Management Act (Act No.107 of 1998) as amended, of intent to carry out the proposed activity. Issues of concern and potential environmental and social impacts will be evaluated during the Basic Environmental Impact Assessment process.

Findings of the Basic Assessment Process, including concerns raised by I&APs, will be submitted to the Limpopo Department of Economic Development, Environment and Tourism (LEDET) for consideration and decision making.

I&APs are hereby invited to comment on the environmental, social and economic issues relating to the proposed Rethuseng Special School development. Your comments will ensure that relevant issues are evaluated and will form part of the Assessment.

DESCRPTION OF THE DEVELOPMENT

Notice is hereby given that Limpopo Department of Public Works, Roads & Infrastructure (LDPWR&I) intends to lodge an Application for Environmental Authorisation in terms of the National Environmental Management Act (Act 107, 1998) (NEMA) with the Limpopo Department of Economic Development, Environment and Tourism (LEDET).

Project Details: Rethuseng Special School, Located on Remaining Extent of Farm Cromford 690-LR, (S: 23°33'11.82", 28°57'23.19"). will comprise of a boarding facility for learners with special needs, boys & girl's dormitories, staff residence, classrooms, laundry, medical building, assembly hall, vocational room, care takers rooms, parking bays, arts and craft centre, ablutions, dining hall, wood and metal centre as well as two sports fields.

LEGAL REQUIREMENTS

The Basic Assessment Process for this assessment will be conducted in accordance with Government Gazette No. R982 in terms of the National Environmental Management Act (Act 107 of 1998) Environmental Impact Assessment regulations of 2014.

The National Environmental Management Act (NEMA) EIA regulations list activities that may have a significant impact on the environment, and which consequently require authorisation from the relevant environmental competent authority. The regulations further specify the assessment process, and the information, that is required to enable LEDET to make an informed decision regarding the proposed activity.

Activities R983 (27), R985 (14), listed under the NEMA EIA regulations (GN R 983), is the main activity associated with the proposed Rethuseng Special School construction, calling for an EIA process to be followed:

GN R.983 Activity (27):

The clearance of an area of 1 hectare or more, but less than 20 hectares of indigenous vegetation,

GN R.985 Activity (12):

The clearance of an area of 300 square metres or more of indigenous vegetation except where such clearance of indigenous vegetation is required for maintenance purposes undertaken in accordance with a maintenance management plan.



WHAT IS AN ENVIRONMENTAL IMPACT ASSESSMENT?

These projects will involve and application for environmental authorization through a Basic Assessment (BA) Process. An Environmental Impact Assessment (EIA) is a planning and decision-making tool that is used to identify the environmental consequences of a proposed project, before the development takes place. The purpose of the EIA (Basic Assessment Process) is to demonstrate to the authorities and the project proponent what the potential consequences of their choices will be in environmental, economic and social terms. Public issues and concerns must therefore be identified timeously so that these can be evaluated and incorporated into the final design if necessary.

The BA Process aims to identify the key project issues raised by the proponent, consultants and the public; consider project alternatives; and through public participation, ensure consensus is reached regarding the issues to be addressed in the BA Process. A Basic Assessment Report (BAR) is produced, which is released to the public for comment. Prior to submission of the final BAR to LEDE, the public is provided with another opportunity to further comment on the matter.

Once the draft BAR has been reviewed by Interested and Affected Parties, comments received are collated and the report is amended as appropriate and finalized. The final BAR is then submitted to the Limpopo Department of Economic Development, Environment & Tourism (LEDET) for consideration.

PUBLIC PARTICIPATION

Public participation is the cornerstone of the Environmental Impact Assessment process. The principles of the National Environmental Management Act (NEMA) govern most aspects of ElAs, including public participation. These include the ongoing provision of sufficient information (in a transparent manner) to Interested and Affected Parties (I&APs).

During the Public Participation Process, input from the proponent, technical experts, government authorities and the public will be gathered to result in a better understanding of the project for all involved, and more informed decision-making throughout the process.

The key objective of public participation is to provide I&APs with an opportunity to provide comment and input in the planning phase of the project. Issues of concern and suggestions raised by I&APs will be addressed and responded to as required in the Draft Basic Assessment Report.

I&APs will also be given the opportunity to comment on the findings of Basic Assessment Report and findings of the Specialist studies during the specified comment periods. I&APs will be provided with a 30-day comment period in which to raise issues and / or concerns in response to the Background Information Document.

A Draft Basic Assessment Report (DBAR) will be compiled and will be available for public comment for a period of 30 days.

Final Basic Assessment Report (FBAR) including Comments and Responses from the public will be submitted to LEDET for decision. I&APs will be notified in writing of any decisions made by LEDET.
